

WILSONART® DURASTEEL™ STAINLESS STEEL SINK LIMITED WARRANTY

WHAT IS COVERED

Wilsonart International Inc. ("Wilsonart") warrants that the Wilsonart® Durasteel™ Stainless Steel Sink is free of defects in material and workmanship. This warranty is extended only for the period of thirty (30) days after the date of purchase by the original purchaser or until the sink is installed, whichever is shorter ("Warranty Period"). This warranty does not cover the sink after it has been installed.

WHAT IS EXCLUDED

This warranty shall not apply to damage arising from any of the following:

- ◆ accidents, abuse or misuse
- ◆ installation, alteration or repairs
- ◆ exposure to chemicals, cleaners or abrasives
- ◆ excessive weight placed in sink;
- ◆ acts of nature

WHAT WILSONART WILL DO IF YOUR CLAIM IS COVERED BY THIS WARRANTY

Wilsonart will provide, with shipping charges prepaid, a Wilsonart replacement sink of like or comparable quality as determined by Wilsonart. Wilsonart will not pay for installation or any other costs.

Replacement under this warranty shall not extend the Warranty Period.

Any replacement under this warranty is limited to replacement with styles of Wilsonart products available at time of replacement. If the original style is no longer available, Wilsonart has the right to substitute another Wilsonart style of equal or greater value than the original product.

WHAT YOU NEED TO DO

To make a claim under this warranty, you must contact the Wilsonart Warranty Center at the address listed below before the end of the Warranty Period. You must provide proof of purchase and make the product available for inspection if necessary for warranty determination.
