

## WETWALL LIMITED LIFETIME WARRANTY

### WHAT IS COVERED:

Wilsonart LLC (“Wilsonart”) warrants that the Wetwall Wall Panel Systems (“Wetwall”) to be free of defects in material and workmanship during normal residential use for as long as the original consumer owns his/her home, provided the shower is installed by a Wetwall Certified Platinum Installer (“Warranty Period”). If Wetwall products are installed outside of the United States of America, Canada, or Mexico or used commercially, Wilsonart warrants that Wetwall will be free from defects in material for three (3) years from the date of sale (“Warranty Period”). To activate this limited warranty, the original consumer purchaser must register their Wetwall online at [Wilsonart.com](http://Wilsonart.com) within thirty (30) days of purchase.

### WHAT IS EXCLUDED:

Wilsonart is not responsible for labor charges, installation, other incidental or consequential costs, or the cost of repair or replacement of any installation materials, including but not limited to tile(s), marble, etc. In no event shall the liability of Wilsonart exceed the purchase price of the Wetwall product. Damages due to improper handling, installation or maintenance are not considered manufacturing defects and are not covered by this warranty. This warranty is valid for the original, consumer purchaser only. Proof of purchase (original sales receipt) must be provided to Wilsonart with all warranty claims.

This warranty shall not apply to damage arising from any of the following:

1. Accidents, abuse or misuse;
2. Exposure to extreme temperature changes;
3. Exposure to harsh or corrosive chemicals and cleaners;
4. Excessive weight placed on or against wall panel;
5. Structural support or movement;
6. Improperly installed, used and/or maintained appliances, fixtures, or accessories;
7. Acts of nature;
8. Failure to use or maintain the product in accordance with Wetwall’s published Care and Maintenance Guidelines (see [www.wilsonart.com/wetwall](http://www.wilsonart.com/wetwall) or information supplied to Wetwall’s distributors and retailers)

### WHAT WILSONART WILL DO IF YOUR CLAIM IS COVERED BY THIS WARRANTY

At no cost to the original consumer purchaser, Wilsonart will provide, at its option, repair or replacement of the warranted product. Neither transfer of residence ownership nor repair or replacement under this warranty shall extend the Warranty Period. Any repair or replacement under the warranty is limited to repair or replacement with Wetwall colors and styles of products available at the time of repair or replacement. If the original color or style is no longer available, Wilsonart has the right to substitute another Wetwall color or style of equal or greater value than the original product. Exact color matches may not be possible.

### WHAT YOU NEED TO DO

To make a claim under this warranty, you must contact the Wilsonart Warranty Center at the address listed below before the end of the Warranty Period. You must provide dated proof of purchase and provide access for inspection for warranty determination. Wilsonart will investigate, and Wilsonart will provide you a determination on your claim.
